It allows us to i) receive, manage and follow up on requests, in liaison with the departments concerned; ii) keep a record of requests and responses made; iii) compile activity data (statistics). This processing is necessary to comply with the legal and regulatory obligations to which HTL is subject. This information may be transmitted internally to all departments likely to be involved in the processing of your request. It will not be transferred outside the European Union. It will be kept for one (1) year from the end of the calendar year of your request. The supporting documents (ID and other documents) will be destroyed after the request is processed. You also have the right to lodge a complaint with the competent authority in matters of personal data, namely in France, the Commission Nationale de l'Informatique et des Libertés.
